GENERAL INFORMATION:

1 ELIGIBILITY

a) Applicant

- **1.1. Thi**s Invitation for Tenders is open to all tenderers eligible as described in the Invitation to Tender. Successful tenderers shall complete the supply of goods by the intended completion date specified in the Schedule of Requirements
- **1.2. The procuring entity's** employees, committee members, board members and their relative (spouse and children) are not eligible to participate in the tender

1.3 Applicants shall not be under a declaration of ineligibility for corrupt and fraudulent practices

1.4 Applicants shall bear all costs associated with and submission of their applications and the college will in no case be responsible or liable for those costs, regardless of the conduct or outcome of the applying process.

1.5 The applicant shall furnish, as part of his /her application, documents establishing the applicant's eligibility to apply and his /her qualification to perform contract if his /her prequalification application is accepted.

1.6 The documentary evidence of the **applicant qualification to perform the contract** if the application for tender is accepted shall be established to the college's satisfaction:

- a) That the applicant has financial, technical and production capability necessary to perform the contract.
- b) That the applicant has an established physical and postal address for ease of contact and he/she is licensed by the Kenyan government to trade in the category applied for.
- c) That the applicant shall declare to be willing to do business with Bumbe Technical Training Institute shall allow credit facilities and acceptable trade terms.
- d) That the applicant is ready and shall offer after sale services for the goods supplied.

b) Tender Prices

1.7 The applicant shall indicate on the appropriate Price Schedule the unit prices of the goods it proposes to supply under the contract.

1.8 Prices indicated on the Price Schedule shall include all costs including taxes, insurances and delivery to the premises of the college.

1.9 Prices quoted by the tenderer shall be fixed for the first ninety (90) days and not subject to variation on any account until after then.

1.1 The validity period of the tender shall be 60 days from the date of opening of the tender.

c) Tender Currency

1.11 Prices shall be quoted in Kenya Shillings unless otherwise specified.

d) Goods Eligibility and Conformity to Prequalification Documents

1.12 The applicant shall furnish, as part of its tender documents establishing the eligibility and conformity to the tender documents of all goods which the tenderer proposes to supply under the contract

1.13 The documentary evidence of the eligibility of the goods shall consist of a statement in the Price Schedule of the country of origin of the goods and services offered which shall be confirmed by a certificate of origin issued at the time of shipment.

2.DEADLINE FOR SUBMISSION OF APPLICATION.

2.1 Application must be received by the college at the address specified on the invitation to apply.

2.2 The college may at its discretion, extend this deadline for the submission of application by amending the application as per regulation governing amendments of tender documents.

3.OPENING OF APPLICATIONS

3.1 The college will open the applications in the presence of applicants or their representatives who chose to attend in the principal board room on the date specified in the invitation to tender

The applicants or representatives who are present shall sign a register evidencing their attendance.

- **3.1** As each tender is opened, the following shall be read out loud and recorded in a document to be called the tender opening register.
 - a) The name of the person /firm submitting the tender.
 - b) If applicable the bid price of the tender including any modification or discount before the deadline for submitting tenders.
 - c) If applicable, what has been given as tender security.

3.2 The college will prepare minutes of tender opening.

4. CLARIFICATION OF APPLICATION

4.1 To assist in the examination, evaluation and comparison of applications, the Institute may at its discretion ask the applicant for clarification of his/her application.

The request for clarification and the response shall be in writing and no change in the substance of the application shall be sought, offered or permitted.

4.2 Any effort by the applicant to influence the college in its application evaluation, comparison or award decisions may result in the rejection of his/her application.

5. EXAMINATION FOR ACCEPTANCE

5.1 Prior to the detailed evaluation, evaluation committee shall determine the substantial, responsiveness of each application on the application documents. A substantially responsive application is one which conforms to all the terms and conditions of application documents without material deviations.

The Institute's determination of applicants' responsiveness is to be based on the content of the application itself without recourse to extrinsic evidence.

5.2 Arithmetical errors will be rectified on the following basis. If there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quantify, the unit price shall prevail, and the total price shall be

corrected. If there is a discrepancy between words and figures the amount in words will prevail.

5.3 If an application is not substantially responsive, it will be rejected by the evaluation committee and may not subsequently be made responsive by the applicant in the correction of the non-conformity.

6. EVALUATION AND COMPARISON OF APPLICATIONS.

6.1 The committee will only evaluate and compare the applications that have been determined to be substantially responsive.

6.2 The evaluation of an application will take into account in addition to the information required on the document the following;

- a) Delivery period offered after receipt of order.
- b) Trade discount allowable
- c) Trade terms (credit facilities and warranty)
- d) Supplier visit report.
- e) Previous suppliers' performance and recommendation by other clients.
- f) Valid trade license and proof of payment of government taxes promptly.

7. CONTACTING THE PROCURING ENTITY

- **7.1 No** applicant shall contact the college on any matter related to its application, from the time of the tender opening to the time the evaluation has been completed.
- **7.2** Any effort by an applicant to influence the college in its decisions on evaluation, comparison & award may result in the rejection of the application.

8. AWARD OF CONTRACT

(a) Award Criteria

8.1 The college will award the contract to the lowest evaluated applicant who meets all the set criteria for evaluation after analysis has been done on the tenders submitted by the applicants.

(b) **Procuring entity's Right to Vary quantities**

8.2 The college reserves the right at the time of contract award to increase or decrease the quantity of goods/services originally specified in the Price Schedule without any change in unit price or other terms and conditions.

(c) Procuring entity's Right to Accept or Reject Any or All Tenders

8.3 The college reserves the right to accept or reject any application and to annul the tendering process and reject all applications at any time prior to contract award, without thereby incurring any liability to the affected applicants or any obligation to inform the affected applicants of the grounds for the Institute's action

9. NOTIFICATION OF AWARD

9.1 The notification of award for supply/service will be communicated to the successful applicant in writing.

10. SIGNING OF CONTRACT

- **10.1** At the same time as the Procuring entity notifies the successful applicant that its application (tender) has been accepted, the college will send the applicant the Contract Form incorporating all agreements between the parties.
- **10.2** The parties to the contract shall have it signed within 14 days from the date of notification of award unless there is an administrative review request.

1. CORRUPT/ FRAUDULENT PRACTICES

- The college requires that applicants observe the highest standards of ethics during the procurement process and the execution of the contract. In pursuance of this policy the college:
 - a) Defines for the purpose of this provision, the terms set forth below
 - b) as follows:
 - i) Corrupt practice"—means the offering, giving, receiving or soliciting of anything of value to influence the action of the Institute officials in the procurement process or in contract including acceptance of this application
 - ii) Fraudulent practice"—means a misrepresentation of facts in order to influence a procurement process or execution of a contract to the detriment of the college and includes collusive practice among suppliers'/service providers (prior to or after application submission) designed to establish item prices at artificial noncompetitive levels and deprive the Institute of the benefit of free and open competition.
 - c) Will reject proposal for award if it determines that the applicant recommended for award (acceptance) has engaged in corrupt or fraudulent practices in competing for the application "acceptance in question"
 - d) Will declare an applicant ineligible, either indefinitely or a taste of period of time to be awarded any college contract if at any time it is determined that the applicant has engaged in corrupt or fraudulent practices in competing for prequalification.
